Project Description:

This project is a safety funded project for intersection improvements on SR-184 (Alexis Rd) at Acres Road and Elliot Rd in Sylvania OH. Work includes new signals, signs and turn lanes. Minor permanent right of way from 1 residential parcel and 2 commercial parcels is anticipated and there will be minor utility impacts. There are required floodplain or US Army Corp of Engineers permits. The project area is urban/commercial and there will be no impacts to any listed species or their habitat due to the work that is being proposed. There is also minimal potential for this project to have any effects on any historical resources. Construction is expected to begin in the summer of 2018 and last approximately 60 days. During construction, a minimum of one lane of vehicular and pedestrian traffic will be maintained at all times with the exception of a 1 week closure of Acres Rd north of SR-184. All impacted residence, public safety agencies, and school officials have been notified of the closure.

This document was written and approved based on Stage 2 plans.
