Project Description:

This paving project improves SR-108, from approximately 2000 feet south of the Putnam County line to the Holgate South Corp line. Work includes removing the existing wearing course, performing necessary pavement repairs, resurfacing, and replacing guardrail. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2020 and last approximately 90 days. During construction, the road will be closed to perform milling and pavement repairs, top course will be done with flaggers. All impacted property owners, schools, and emergency personnel have been notified.

This document was written and approved based on Stage 2 plans.
