The surface preservation by pavement planing, base repair, and asphalt resurfacing of CH 0606 (Washington Street) in Bainbridge Township Geauga County, from the South Russell Village to Chillicothe Road (SR 306). This roadway is curbed and existing curbing shall remain. Limited curb inlets may require adjustment to meet final asphalt surface, but no other drainage related work will be part of this project.

All work within existing r/w.

No deep excavation.

No work in streams, wetlands, or pollinator initiative sites. No tree removal.

Construction: \$426,025 80% Federal and 20% Local.

C1 approval is based on Stage 3 design.
