In collaboration with ODOT, the City of Tiffin proposes a roadway improvement project in Tiffin, Seneca County, Ohio. The proposed project will involve full-depth pavement reconstruction of North Sandusky Street (State Route 53) from Hall Street to Tomb Street, including striping, signage upgrades, and structure adjustments. Additionally, North Sandusky Street will be resurfaced between Tomb Street and Rita Lane. The project will also involve improvements to the intersection of North Sandusky Street, North Washington Street, and East and West Davis Streets, including upgrading existing signal equipment, providing pedestrian push buttons, and optimizing signal phasing and timing.

This project will require no new right-of-way. Property takes/relocation are not required to construct the project. No deep excavation will be required. The current estimated project cost, including construction is \$2,592,789 with an anticipated award date in 2025.

Coordination with ODOT Office of Environmental Services (OES) was completed to review the Regulated Materials Review (RMR) Screening. On August 19, 2024, ODOT-OES determined that no further RMR or special material management is warranted for this project.

ODOT environmental staff conducted a literature search, and on August 27, 2024, in accordance with Stipulation V(C) (1) and Appendix B of the Section 106 Programmatic Agreement executed on June 29, 2023 (Agreement No. 38503), ODOT-OES determined that the proposed project has 'minimal potential to cause effects to historic properties.'

No water resources or endangered species habitat was identified within the project area; therefore, no impacts are anticipated to these resources.

Property owner notification letters describing the project and the proposed detours were sent on October 3, 2024. Additionally, local schools, hospitals, and EMS were notified of this project and the detours on October 3, 2024. The public was invited to comment on the project until November 6, 2024. One question was received regarding maintenance of access to a business, and the City of Tiffin provided a response. A copy of the letters, local detour mapping, mailing lists, and comment are included in the project file.

The work will be completed in six phases to expedite construction, minimize disruption to adjacent property owners and businesses, and provide a safe work zone for the contractor. Only one phase of work will be completed at a time. A minimum of one lane of traffic and pedestrian access will be maintained through the construction zone at all times. Additionally, local and out of town detours will be maintained throughout the duration of construction. Local detours are provided in the Detour Mapping in the project file. The out-of-town detour will utilize State Route 18, State Route 635, and State Route 12. Prior to construction, advanced notification will be provided to inform roadway users of the anticipated dates of construction. Construction is expected to begin in April 2026 and require up to eight (8) months to construct (December 2026).

The NEPA document and associated studies are being approved using Stage 1 engineering design plans. A copy of the plans can be found in the project file.

Every effort was made to include all identified groups, including environmental justice populations, in the decision-making process for this project. Based on a review of ODOT's Transportation Information Mapping System (TIMS) on July 29, 2024, environmental justice populations were identified within the proposed project area (see above table). Based on a review of the U.S. Department of Housing and Urban Development (HUD) resource locator, no HUD properties were identified within the proposed project area. One HUD property is located adjacent to the proposed project area. A minimum of one lane of traffic will be maintained at all times and pedestrian access will be maintained through the construction zone at all times. The project will not result in any displacements or in any permanent restrictions to access by environmental justice populations.

The proposed project will have no disproportionately high and adverse effects to minority or low-income populations or disparate impacts to a Title VI population based upon the table above and the attached mapping. No concerns related to impacts on environmental justice or Title VI populations were raised as a result of public involvement activities conducted as part of the proposed project. Therefore, in accordance with the protections of Executive Order 12898, FHWA Order 6640.23A and Title VI of the Civil Rights Act of 1964, no further analysis is required. Furthermore, the proposed project will also have no substantial impacts to Limited English Proficiency, Older Adults, or Individuals with Disabilities Populations. No concerns related to impacts on these environmental justice populations were raised as a result of public involvement activities conducted as part of the proposed project. Therefore, in accordance with the protections of the Age Rehabilitation Act of 1973, Discrimination Act of 1975, Americans with Disabilities Act of 1990, and Executive Order 13166, no further analysis is required. Project notification occurred for environmental justice populations and the general public, including property owner letters (see Project file: Public Involvement/Property Owner Notification Letter.pdf).
