The Ohio Department of Transportation is proposing to purchase 2 parcels (total of 12.9 acres) in Napoleon, Henry County, Ohio for the future site of a new full service maintenance facility. There will be no utility impacts or permits required due to this purchase. There will be no impacts to any state or federally listed species or their habitat. There were also no records of any historic resources on these parcels so there will be minimal potential to impact any significant resources. There will be no traffic disruptions as a result of this project. Construction of a new facility will be evaluated under a separate project ID number.
