Project Description:

The Ohio Department of Transportation (ODOT) is proposing to do full depth pavement repairs along various routes in Lucas, Williams, and Wood Counties. These repairs will not require right of way and will not impact utilities. There will be no impacts to any waterways so no permits from the US Army Corps of Engineers is required. This project does pass through several floodplains, however the district hydraulic engineer determined that there would be no impact. One of the Lucas County locations is within the Oak Openings region. A plant survey was conducted to determine if any listed plant species would be impacted by this project. It was determined that there was no suitable habitat for these species and that there would be no impacts (documentation in file). Since there is no work outside of the right of way and there are no historic districts near this project, there is minimal potential to cause effects on historical resources. Construction is expected to begin in summer 2019 and last approximately 60 days total. During construction, a minimum of one lane will be maintained at all times.

1) The Project Designer shall incorporate the following note into the plans: The contractor shall take all precautions to prevent any and all material from going off the edge of bridge deck(s) and edge of culvert(s) during all construction operations. The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.

2) The project designer shall include a note in the construction plans to address the project's location in relation to the drinking water source.
