Project Description:

The Ohio Department of Transportation is proposing to repair a slide on the west side of Fulton Street from Wilcox Rd and SR-2 in Ottawa County OH. All work is within the existing right of way and no utility impacts are anticipated. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin in the summer of 2019 and last approximately 60 days. During construction, a minimum of one lane of traffic will be maintained at all times.
