Project Description:

The Wood County Engineers Office is proposing to install new guardrail at 3 locations within Wood County:

1. Sand Ridge Road from Custar Road to Milton Road
2. Poe Road from west of Carter Road to SR-105
3. Pemberville Road near Recker Road

There will be no new right of way or utility impacts associated with this project. Each project location is near jurisdictional streams, however there will be no impacts below the ordinary high water mark of the resources so no permits are required. None of the locations are within floodplains. There will be no impacts to any state or federally listed species and there is minimal potential to effect any historical resources. Construction is expected to begin in the summer of 2019 and last approximately 60 days. During construction, a minimum of one lane of traffic will be maintained at all times.

1) The LPA project designer shall incorporate the following note into the plans: The contractor shall take all precautions to prevent any and all material from going off the edge of bridge deck(s) and edge of culvert(s) during all construction operations. The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.

2) The LPA project designer shall incorporate the following note into the plans: No work (temporary or permanent) shall be performed below the Ordinary High Water Mark of any stream. Any work below the OHWM is a violation of the Federal Clean Water Act of 1972.
