Project Description:

The Ohio Department of Transportation (ODOT) proposes to resurface 3.33 miles of State Route (SR) 86 from the Ashtabula County/Geauga County Line at Straight Line Mile (SLM) 0.00, approximately 0.06 mile west of Chardon-Windsor Road, to SR 534 at SLM 3.33 in Windsor Township, Ashtabula County. The project also proposes partial depth pavement repair, full depth pavement repair, linear grading and installation of new pavement markings.

During project construction, a minimum of one ten (10)-foot bidirectional lane of traffic shall be maintained on the existing pavement and completed pavement. Road closures and detours are not proposed to construct the project. Access shall be maintained to all properties during project construction. Maintenance of traffic information will be posted within the project limits prior to the start of construction. Substantial traffic disruptions are not expected with the project.

The project will be constructed within the existing roadway right-of-way.

Existing utilities within the project study area will not be impacted/relocated to construct the project.

Based on the project scope of work, its Path 1 Preliminary Development Process (PDP) Classification and the proposed maintenance of traffic measures, emergency/public services contact activities were not conducted for the project.
