Project Description:

This project includes the sealing of 31 structures on I-75 in Wood and Lucas Counties. All work is within the existing right of way and there will be no impacts to any utilities. Since all work will be performed above the water, no permits from the Army Corp of Engineers or floodplain permits are required. There will be no impacts to any ecological resources. One of the structures is eligible for the national register of historic places, however it was determined that the proposed work would have minimal potential to cause effects. Construction is expected to begin in the spring and last approximately 120 days total. During construction, a minimum of one lane will be maintained at all times on the structures.

This document was written and approved based on Stage 2 plans.

The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.
