Project Description:

The City of Toledo is proposing to pave 0.86 miles of CR-2231 (York Street). The work includes removing the existing wearing course, full depth reconstruction, replacing curb ramps, side walks and drainage as needed. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The project is located within the Birmingham Historic district, however the work included in this project will have minimal potential to cause effects to historical resources. Construction is expected to begin spring of 2020 and last approximately 150 days. During construction, a minimum of one lane of vehicular will be maintained at all times. Pedestrian traffic will also be maintained at all times.
