**Description of Parcel Being Disposed**

Limited access right-of-way acquired in 1967 for construction of Interstate Route (IR) 77. The excess land is adjacent to northbound IR 77 near the IR 77/IR 80 (Ohio Turnpike) interchange in the village of Richfield, Summit County. The land was acquired to construct an exit ramp from westbound IR 80 to northbound IR 77, however, the ramp was constructed in a different location. Therefore, the land is no longer necessary. It is approximately 3.46 acres and primarily forested with no structures.
