Project Description:

This project will resurface 3.7 miles of pavement on Alexis rd, from Flanders road to Jackman road. This includes removing and replacing the pavement, curb and gutter and the drive approaches as well as minor drainage improvements. All work is within the existing right of way and there will be impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area so a permit will be acquired by the City of Toledo before construction begins. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer or 2020 and last approximately 90 days. During construction, a minimum of one traffic lane will be maintained at all times.
