Project Description:

The Ohio Department of Transportation is proposing to repair approximately 250 feet of failed embankment on north side of SR 110 immediately east of bridge spanning US 6. All work is within the existing right of way and there will be no impacts to utilities. No jurisdictional water resources will be impacted by the project so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin fall of 2020 and last approximately 60 days. During construction, a minimum of one traffic lane will be maintained at all times.

The contractor shall immediately remove through non-mechanical means any material that falls into the roadside ditches, streams, wetlands, or other waters. Under no circumstances shall the contractor work in or store equipment and/or materials in any wetlands, streams, or other waters. No work or staging is permitted below the top of bank of any stream and/or within a wetland.
