Project Description:

This paving project improves SR-579, from the Wood County line to SR-2 in Ottawa County. Additional work includes guardrail replacement, embankment repair (above OHWM) on bridge over Crane Creek, possible no parking sign replacement/removal, replace catch basins, and new mats for curb ramps. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area, however the district hydraulics engineer determined that there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2020 and last approximately 60 days. During construction, a minimum of one lane of traffic will be maintained at all times.
