Project Description:

ODOT is proposing to resurface SR-25 from SR-582 to Roachton Rd. Additional work includes replacing the culvert under NB SR-25 at Five Point Rd. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin spring of 2020 and last approximately 60 days. During construction, there will be a 5 day closure of SR-25 NB at Five Point Rd. due to the culvert replacement. All impacted public safety agencies, schools, and residents have been notified of the closure.

This document was written and approved based on Stage 2 plans.
