Project Description:

The Wood County Engineer is proposing to reconstruct Oregon Road from the Ohio Turnpike overpass to Wales Road. Additional work includes signing, striping, sidewalks, signal work and minor drainage improvements. All work is within the existing right of way and there will be no impacts to utilities. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There are no waterway impacts within the project area so no permits are required from the USACE. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2021 and last approximately 60 days. During construction, there will be lane closures throughout the project limits.

This document was written and approved based on Stage 1 plans.
