Project Description:

The City of Oregon is proposing to resurface Star Avenue (County Road 555) from S. Whittlesey Ave to S. Lallendorf Rd. Additional work includes adjustments to manholes and catchbasins. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2020 and last approximately 30 days. During construction, a minimum of one traffic lane will be maintained at all times.
