Project Description:

This paving project improves 0.80 miles of US-20, from East Boundary St to Indiana Ave (SR-795), and 0.36 miles of SR-25 between Craig Drive and Findlay St. Work includes removing the existing wearing course, performing necessary pavement repairs, resurfacing, replacing curbs and loop detectors and new thermoplastic markings. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2020 and last approximately 60 days. During construction, a minimum of one traffic lane will be maintained at all times.
