Project Description:

This paving project improves SR-269, from SR-2 to SR-163. Work includes removing the existing wearing course, performing necessary pavement repairs, and resurfacing. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area however the district hydraulic engineer determined that there will be no impacts. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin spring of 2021 and last approximately 90 days. During construction, a minimum of one traffic lane will be maintained at all times.
