Project Description:

The Williams County Engineer is proposing to resurface CR-14 (R) from CR-7 to SR-576 and CR-27 (G) from SR-34 to SR-15. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area and a floodplain permit has been obtained. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2020 and last approximately 60 days. During construction, a minimum of one traffic lane will be maintained at all times.

This document was written and approved based on Stage 1 plans.
