Project Description:

The Ohio Department of Transportation is proposing to resurface State Route 108 in Fulton County from the Henry County line into Wauseon. Additional work includes the replacement of a tile under SR-108 near County Road D and guardrail replacement. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area. All federal, state, and local floodplain regulations will be followed. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2021 and last approximately 90 days. During construction, a minimum of one traffic lane will be maintained at all times on State Route 108 except for a 30-day closure for the tile replacement near County Road D. All impacted residents, public safety agencies, and schools have been notified of the closure.

This document was written and approved based on Stage 2 plans.
