Project Description:

The Ohio Department of Transportation is currently proposing to resurface a portions of SR-18 in Seneca County due to poor pavement conditions. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterway or floodplains, therefore no US Army Corps of Engineers or floodplains permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the Spring of 2024 and last approximately 150 days. During constructions, one lane of traffic will be maintained at all times.

This document was approved based on Stage 2 Plans.
