Project Description:

The Ohio Department of Transportation (ODOT) proposes to improve the US 20 Reynolds Road and Heatherdowns Boulevard intersection in the City of Toledo, Lucas County. The improvements will address access management and traffic issues by upgrading signals, providing protected left-turn movements, restriping the intersection for double turn lanes, and installing median barriers on Heatherdowns Boulevard to restrict certain turning movements. Sidewalks will be upgraded as needed, and the associated roadway will be repaved.

Minor permanent right of way from three parcels and minor temporary right of way from nine parcels will be required for this project. Some impacts to utilities are expected. During construction, a minimum of one lane of traffic in each direction will be maintained. Access to businesses will be maintained at all times during construction.

There are no jurisdictional water resources in the project area, so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area, so there will be no impacts to any ecological resources. No other environmental, hazardous materials, Section 4(f)/6(f), cultural resources, or underserved population impacts will result from this project.

Construction is expected to begin in fall 2021 and last approximately 6 months.

Letters were sent to the adjacent property owners on October 23, 2019 to provide project information and an opportunity to comment on the project. No comments were received.

The environmental document and associated studies are being approved using Stage 2 Design. A copy of the plans is included in the project file.
