Project Description:

The City of Toledo is proposing to resurface Airport Highway (State Route 2) from Byrne Rd to South Ave. This also includes curb and gutter replacements, replacing drive approaches, as well as minor drainage improvements. All work is within the existing right of way and there will be impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2021 and last approximately 60 days. During construction, a minimum of one lane of traffic will be maintained at all times.

This document was written and approved based on Stage 1 plans.
