Project Description:

The Ohio Department of Transportation (ODOT) is currently proposing to replace the deck (driving surface) for the bridges that carry Gypsy Lane Road and Poe Road over Interstate 75 in Wood County. All work is within the existing right of way and there will be no utility impacts. There are no impacts to any jurisdictional waterways or floodplains so no permits are required. This project will not impact any state or federally listed species or their habitat. The work included in this project has minimal potential to effect historic resources. Construction of this project is anticipated to take place in summer of 2021. During construction, each bridge location will need to be closed for approximately 90 days to complete the work. A detour will be posted. All impacted residents, businesses, public safety agencies, and schools have been notified of the road closures.

This document was written and approved based on Stage 2 plans.
