Project Description:

The Ohio Department of Transportation is proposing to overlay the bridge that carries the I-75 N ramp over the Ohio Turnpike near State Route 795 in Wood County. All work is within the existing right of way and utility impacts are possible. This project is not located within a special flood hazard area so no permits or documentation is required. No streams, jurisdictional ditches, or wetlands will be impacted so no USACE permits are required. There is no impact to suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer 2020 and last approximately 5 days. During construction, the will be closed and a detour will be posted. All impacted EMS/Fire and police have been notified of the closure.

This project was written and approved based on Stage 2 plans.
