Project Description:

The City of Toledo is proposing to install a gateway structure and plantings at the entry to the city on Reynolds Road between the Ohio Turnpike and Heatherdowns Blvd. All work is within the right of way and utility relocation is expected. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is not located within a special flood hazard area so there will be no impacts to the floodplain. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin fall of 2020 and last approximately 45 days. During construction, a minimum of one lane of traffic will be maintained at all times.

This document was written and approved based on Stage 1 plans.
