Project Description:

ODOT proposes to resurface State Route 64 from State Route 120 to US Route 20 and State Route 120 from County Road 3 to County Road 2. All work is within the existing right of way and there will be no impacts to any utilities. There will be no impacts to any waters of the US but this project is located within a floodplain. All federal and state floodplain regulations will be followed throughout the project. This project has minimal potential to cause effects to any historical resources and there will be no impacts to any listed species or their habitats. The project will begin in the spring of 2021 and take approximately 120 days. During construction, a minimum of 1 lane of traffic will be maintained at all times.

This document was written and approved based on stage 2 plans.
