Project Description:

The Ohio Department of Transportation is proposing to resurface US Route 20A from the Delta Corporation Limits to County Road 3 and State Route 109 within the Village of Delta limits. Additional work includes the replacement of curb ramps. All work is within the existing right of way and there will be no impacts to utilities. There are no jurisdictional water resources in the project area so no USACE permits are required. This project is located within a special flood hazard area and all federal, state, and local regulations will be followed throughout construction. There is no suitable habitat for any state or federally listed species within the project area so there will be no impacts to any ecological resources. The work included in this project has minimal potential to cause effects to historical resources. Construction is expected to begin summer of 2021 and last approximately 90 days. During construction, a minimum of one traffic lane will be maintained at all times.
