Project Description:

The Ohio Department of Transportation is proposing to resurface US Route 23 from Cygnet Road to US-6 in Wood County. Additional work includes minor curb ramps and drainage improvements. All work is within the right of way and there will be no impacts to utilities. There is no work within any waters of the US or special flood hazard areas so no permits are required. There will be no impacts to any state or federally listed species or their habitat and this project has minimal potential to cause affects to any historical resources. Construction is expected to begin the summer of 2021 and last approximately 90 days. During construction, a minimum of 1 lane of traffic will be maintained at all times.

This document was written and approved based on Stage 2 plans.
