Project Description:

The Ohio Department of Transportation is proposing to paint wet reflective pavement markings, including recessed and non recessed, on multi-lane facilities throughout the district. All work is within the right of way and there will be no impacts to utilities. There are no impacts to any ecological resources (streams, wetlands, listed species) or historical resources. Several of the routes are located within a special flood hazard area, however the work will have no impact on the floodplain. Construction is expected to begin in the spring of 2021 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.
