Project Description:

The Ohio Department of Transportation is proposing to resurface State Route 281 from State Route 235 to Township Road 118 in Wood County. All work is within the right of way and there will be no impacts to utilities. There is no work within any waters of the US and there are no floodplain impacts so no permits are required. There will be no impacts to any state or federally listed species or their habitat and this project has minimal potential to cause effects to any historical resources. Construction is expected to begin the summer of 2021 and last approximately 60 days. During construction, a minimum of 1 lane of traffic will be maintained at all times. This document was written and approved based on Stage 2 plans.
