Project Description:

The Ohio Department of Transportation District 2 is proposing to resurface various route throughout Wood County and perform necessary related work. The work being done on PID 111253 will be combined with the work for this project. All work is within the right of way and there will no impact to utilities. There is no work within any waters of the state or US and there are no floodplain impacts so no USACE permits will be required. There will be no impacts to any state or federally listed species or their habitat. This project also has a minimal potential to cause affects to any historical resources. Construction is expected to begin in spring of 2022 and last approximately 90 days.
