Project Description:

This project is an annual contract to replace raised pavement markers throughout the district. All work is within the right of way and there are no utility impacts. Several locations are within special flood hazard areas, however the district 2 hydraulic engineer determined that there would be no impacts to the floodplain. No permits from the US Army Corps of Engineers are required due to no work within any waters of the US. There will be no impacts to any ecologically or historically significant resources due to this project. Construction will begin in the spring of 2022 and last through the fall of 2022. During construction, there will be rolling lane restrictions.

This document was approved based on Stage 2 plans.
