The Ohio Department of Transportation District 2 is proposing a project to install recessed wet reflective pavement markings on various routes throughout the district. Necessary related work will also be performed. All work is within the existing right of way and there will be no impact to utilities. There is no work within any waters of the state or the US and there are no floodplain impacts no USACE permits will be required. There will be no impacts to any state or federally listed species or their habitat. This project also has a minimal potential to cause affects to any historical resources. Construction is expected to begin in spring of 2022 and last approximately 45 days.
