Project Description:

The Ohio Department of Transportation District 2 is proposing a contract to repair concrete pavement at various locations within the district. All work is within the existing right of way and there will be no impacts to utilities. There is no work within any waters of the state or the US and there are no floodplain impacts so no USACE permits will be required. There will be no impacts to any state or federally listed species or their habitat. This project also has a minimal potential to cause affects to any historical resources. Construction is expected to begin in spring of 2022 and last approximately 90 days.
