Project Description:

The City of Sylvania in partnership with the Ohio Department of Transportation District 2 is proposing a project to widen and install turn lanes at the intersection of State Route 25 and Indiana Avenue in Wood County. All work is within the existing right of way and there will be no impact to utilities. There is no work within any waters of the state or the US and there are no floodplain impacts no USACE permits will be required. There will be no impacts to any state or federally listed species or their habitat. This project also has a minimal potential to cause affects to any historical resources. Construction is expected to begin in summer of 2022 and last approximately 60 days.
