Project Description:

ODOT District 2 is proposing a project to resurface State Route 2 in Ottawa County from State Route 358 to State Street Overpass. All work is within the right of way and there will be no impact to utilities. There is no work within any waters or the state of US and there are no floodplain impacts so no USACE permits or floodplain coordination will be required. There will be no impacts to any state or federally listed species or their habitat. This project also has a minimal potential to cause affects to any historical resources. Construction is expected to begin in spring of 2022 and last approximately 120 days.
