Project Description:

The Wood County Engineer is currently proposing to paint pavement markings on various county routes in Wood County due to the need for yearly maintenance. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2022 and last approximately 45 days. During construction, one lane of traffic will be maintained at all times. This document was approved based on Stage 1 Plans.
