Project Description:

ODOT is proposing to resurface State Route 53 from State Street to Water Street in Ottawa County. Areas between State Street and State Route 163 will require full depth pavement repairs. All work is within the existing right of way and there will be no impacts to utilities. This project is located within a special flood hazard area. It was determined by the district 2 hydraulic engineer that there would be no impacts to the floodplain. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the fall of 2022 and last approximately 45 days. During construction, one lane of traffic will be maintained at all times.

This document was written and approved based on Stage 2 plans.
