Project Description:

A resurfacing project to mill and fill SR-25 from BG North Corp Line to SR-582 with some minimal pavement repairs. All work is within right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in summer of 2022 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times. This document has been written and approved based on stage 2 plans
