Project Description:

A project to resurface SR-231 in Seneca County. There will be no deep excavation. All work is within existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the fall of 2022 and last approximately 45 days. During construction, one lane of traffic will be maintained at all times.
