Project Description:

A district allocation funded 2-lane project to resurface SR-19 from Fremont Corp Line to the Sandusky-Ottawa County Line. All work is within the existing right of way and there will be no impacts to utilities. The project does pass through several floodplains however, there will be no impacts to those floodplains. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2023 and last approximately 165 days. During construction, one lane of traffic will be maintained at all times.
