Project Description:

A project to resurface two country roads. The first is CR-22 from CR-D to US-20A then CR-23 from CR-J to US-20A. There will be no deep excavation. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2022 and last approximately 60 days. During construction, one lane of traffic will be maintained at all times.

This document was written and approved based on Stage 2 plans.
