Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR 12 from County Line Rd to Main St within the City of Fostoria in Seneca County due to poor pavement conditions. All work is within existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer of 2024 and last approximately 45 days. During construction, one lane of traffic will be maintained at all times.

This document was approved based on Stage 3 Plans.
