Project Description:

The City of Toledo is currently proposing a safety project to improve the intersection of Dorr St (SR 246) and Detroit Ave (US 24) by upgrading the signal, installing a median to restrict left turns from Junction Ave, installing overhead sign structures, and lighting for pedestrians and resurfacing the intersection. All work is within the existing right of way and there will be no impacts to utilities. This project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the Spring of 2023 and last approximately 60 days. During construction, one lane traffic will be maintained at all times.
