The Ohio Department of Transportation (ODOT) proposes to install recessed wet reflective pavement markings along a U. S. Route (USR) and various interstate and state routes in Cherry Valley, Colebrook, New Lyme and Wayne Townships, Ashtabula County, in Brookfield, Greene, Gustavus, Hubbard, Johnston, Liberty and Vienna Townships, Trumbull County, in Austintown, Jackson and Milton Townships, Mahoning County and the city of Massillon and Perry and Tuscarawas Townships, Stark County, as follows:

1. ATB SR 11 from Straight Line Mile (SLM) 0.00 to SLM 8.05;
2. TRU SR 11 from SLM 19.02 to SLM 28.47;
3. TRU SR 11 from SLM 7.68 to SLM 9.97;
4. TRU SR 82 from SLM 22.74 to SLM 29.87;
5. TRU IR 80 from SLM 8.56 to SLM 12.33;
6. MAH IR 80 from SLM 0.00 to SLM 5.02;
7. MAH IR 76 from SLM 3.53 to SLM 8.65; and
8. STA USR 30 from SLM 0.00 to SLM 9.61.

Additional improvements proposed by this project include new edge line/lane line/stop line/channelizing line/dotted line/other pavement marking applications.

Mapping that depicts the project location on United States Geological Survey (USGS) 7.5-Minute Topographic Quadrangle Mapping is included in Project File/General/Project Information as USGS Quadrangle Topographical Map.pdf.

On highways/roadways with 3 or more lanes, a minimum of one ten-foot lane of traffic in each direction shall be maintained on the existing pavement and completed pavement during project construction. On roadways with 2 lanes, a minimum of one ten-foot bidirectional lane of traffic shall be maintained on the existing pavement and completed pavement during project construction. The duration of lane closures/restrictions shall be prescribed by the permitted lane closure chart. Construction and lane restriction/reduction information will be posted within the project construction limits prior to the start of project construction. Lane restrictions/reductions shall not be permitted after normal working hours. Substantial traffic disruptions are not expected during project construction.

The project will be constructed within the existing highway/roadway rights-of-way.

Existing utilities within the project study areas will not be impacted/relocated to construct the project.

Based on the project scope of work, its Path 1 Project Development Process (PDP) Classification and the proposed maintenance of traffic measures, emergency/public services contact activities were not conducted for the project.

A Cultural Resources Records Check was performed by district environmental staff using the SHPO GIS online database. No Cultural Resources listed on or determined eligible for listing on the National Register of Historic Places were identified within and/or immediately adjacent to the proposed project area. The undertaking is a type that has minimal potential to cause effects to historic properties. No further coordination is required in accordance with the Section 106 Programmatic Agreement. In accordance with Stipulation V(C)(1) and Appendix A of the Section 106 Programmatic Agreement executed on November 8, 2017 (Agreement No. 19319), amended on July 11, 2019, ODOT determined the project is a type of undertaking that has 'minimal potential to cause effects' to historic properties and is not a part of a larger undertaking. See the cultural resources documentation for the project in the Project File/Cultural Resources/Project Information subsection and the Cultural Resources Tab.

Based on the information in the Regulated Materials Review (RMR) Form completed for the project, further RMR activities or special materials management are not warranted for the project. See the RMR documentation for the project in the Project File/ESA/Reports subsection.

Additionally, this project is considered ecologically exempt under the Ecological MOA (Agreement 19394). See the Ecologically Exempt D04-PM R-WR-FY2022.pdf for the project in the Project File/Ecological/Reports subsection.

The work proposed by the project is considered maintenance and, therefore, is exempt from the normal permit process required for work encroaching on a special flood hazard area (SFHA). Floodplain coordination is not required for the project. See the floodplains documentation for the project in the Project File/Permits/Floodplains subsection.

The project will not impact any environmentally sensitive resources within the project study areas.

The environmental document and associated studies, as applicable, were approved using the Stage 3 Design plans for the project. A copy of the Stage 3 Design plans for the project is included in the Project File/General/Project Information subsection as Stage 3 Design.pdf.

The estimated total project cost specified in Ellis is 39.45% greater than the total project cost specified in the ODOT State Fiscal Years 2021 - 2024 Statewide Transportation Improvement Program (STIP). However, fiscal constraint is at the Statewide Line Item (SLI) Group level. Therefore, an individual project utilizing a SLI does not require a STIP/TIP amendment.

## **Environmental Commitments**

1) The project designer shall incorporate the following note into the plans: The Drinking Water Source Protection Area - Inland Surface Water Corridor Management Zone of the Mahoning Valley Sanitary District is located within the project limits. Use proper containment and diking in refueling areas established for the project. Do not store fuels, toxic/hazardous materials and chemicals near drainage ways, ditches or streams. Maintain a spill kit on-site throughout construction activities. Immediately mitigate any event, such as a spill of fuels, oils or chemicals, that could threaten to contaminate the drinking water supply. Report all spills or events to the Mahoning Valley Sanitary District at (330) 652-3614. If the spill is a reportable amount (per Ohio EPA Release Reporting Requirements), contact the Mahoning County Emergency Management at 330-726-4155 or the Ohio EPA Spills Hotline at 800-282-9378 for clean-up of the spill.
