Project Description:

The Ohio Department of Transportation is currently proposing to resurface SR19 from Portage River to Oak Harbor village limits and SR-163 from near SR-590 to Oak Harbor village limits in Ottawa County due to poor pavement conditions. All work is within the existing right of way, and there will be no impacts to utilities. The project does not include impacts to any waterways or floodplains, therefore no US Army Corps of Engineers or floodplain permits are required. There will be no impacts to any ecological or historically significant resources. Construction is expected to begin in the summer 2023 and last approximately 105 days.

This document has been written and approved based on Stage 2 Plans.
