This proposed project includes district wide (Henry, Fulton, Lucas, Ottawa, Sandusky, Seneca, Wood, and Williams County) pavement marking maintenance to re-paint pavement markings. This project will not impact any waters of the US or special flood hazard areas so no permits are required. Some locations are within 1,000 feet of the State Scenic Maumee and Sandusky Rivers however, this activity is an exempt activity and no notifications to the Ohio Department of Natural Resources (ODNR) Scenic Rivers are required. Extra care will be taken to not disturb any plants/animals, especially within the Oak Openings region. This project will not have any impacts on any historically significant resources. Construction is expected to begin in the spring of 2024 and continue through the summer of 2024. The public will be notified of any traffic disruptions.
